# POLYMER COMPOSITE CLEANER

Especially developed for composite decking!









#### PRODUCT DESCRIPTION

Highly effective, lightly alkaline specialized cleaner for removing organic and inorganic contaminations in outdoor areas. Ideal for the intensive cleaning of WPC/BPC decking and all other wood-polymer composites in outdoor areas.

#### RECOMMENDED USE

Osmo Polymer Composite Cleaner was especially developed to clean WPC and BPC decking and other waterproof surfaces in outdoor areas, such as garden furniture and fencing made of synthetic materials.

#### **INGREDIENTS**

Alkaline basic cleaner: <5% cationic tensides; nonionic tensides; silicates; complexing agents; NTA and additives. Detailed declaration of ingredients available upon request.

#### TECHNICAL DATA

Specific gravity: 1.05-1.10 g/cm³ Viscosity: 20-25s DIN 53211/3 mm Odour: faint/mild, after drying odourless

pH value (10g/l): 10.9

#### **STORAGE**

Up to 2 years and longer if container is kept dry, closed tightly and stored at temperatures between 5 and 35°C. Do not expose to frost during transport!

#### SURFACE PREPARATION

Remove dust and debris from the surface with a firm broom/hand broom.

Dilute concentrate from 1:10 to 1:20 with water. A trial application is absolutely necessary!

#### METHOD OF APPLICATION

Apply the cleaning solution to the contaminated surface, and loosen dirt with Osmo Decking Cleaning Brush. After 10 minutes reaction time, rinse thoroughly with clear water. For machine processing on decking, we recommend using the Osmo Decking and Flooring Cleaning Machine.

Always use on the complete area! Do not use undiluted!

#### **CLEANING OF TOOLS**

Immediately after use, with soap and water.

#### COVERAGE

1 litre covers approx. 10-50 m<sup>2</sup> for one application (depending on the level of contamination).

#### NOTE

Do not use undiluted. Osmo Polymer Composite Cleaner can lead to discolourations or surface changes on unfamiliar substrates. If all possible, use on the complete area. Avoid allowing the solution to dry. Not suitable for everyday cleaning and maintenance. Avoid direct contact with ornamental and farm plants.

#### **CAUTION**

Contains: Disodium metasilicate. Causes skin irritation. Causes serious eye damage. Reacts with acids with evolution of heat. Risk of splashing! The general safety regulations when handling chemicals must be observed. Keep out of reach of children. Read label before use. Wear protective gloves/eye protection. If in eyes: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If on skin: Wash with plenty of soap and water. If medical advice is needed, have product container or label at hand.
