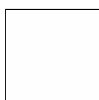




WPC & ALUMINIUM CLEANER

Especially developed for polymer composite decking as well as polymer composite and aluminium privacy fencing!

Product description:

Highly effective, slightly alkaline, specialised cleaner for removing organic and inorganic deposits in the exterior. Ideal for the intensive cleaning of WPC/BPC decking, anodised and laminated aluminium profiles and all other wood-plastic composites in outdoor areas.

Recommended use:

Osmo WPC & Aluminium Cleaner was especially developed to clean WPC and BPC decking and other waterproof surfaces in outdoor areas, such as garden furniture and fencing made of synthetic materials and aluminium. Not suitable for co-extruded surfaces.

Ingredients:

Alkaline cleaner: <5% cationic surfactants; non-ionic surfactants; silicates; complexing agents and additives. Detailed declaration of ingredients available upon request.

Storage:

2 years or longer if stored in the originally closed container. Do not expose to frost or temperatures above 30 °C!

Surface preparation:

Remove dirt and debris with a broom/hand brush from the surface. Dilute concentrate with water, 1:10 - 1:20. Please always check product compatibility with the substrate!

Methods of Application:

Apply the cleaning solution to the dirty area, if necessary carefully remove loose dirt, and wait 10 minutes for the solution to react. Afterwards rinse thoroughly with clear water. For machine applications on decking, Osmo Flooring and Decking Cleaning Machine is recommended. Always apply to the entire surface! Do not use undiluted!

Cleaning of tools:

With soap and water.

Drying time:

Approx. 24 hours (normal climatic conditions, 20-23°C/50-65% rel. humidity). Ventilate well while drying. Lower temperatures and/or higher air humidity may increase drying times significantly.



Coverage:

1 litre covers approx. 10-50 m² for one application (depending on the level of contamination).

Note:

Do not use undiluted. May cause discolorations or surface changes when used on unknown substrates. Do not allow solution to dry. Not suitable for daily cleaning. Avoid direct contact with ornamental and farm plants.

Caution:

Causes skin irritation. Causes serious eye damage. Reacts with acids with evolution of heat. Risk of splashing! If medical advice is needed, have product container or label at hand. Keep out of reach of children. Wear protective gloves/eye protection. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Contains disodium metasilicate, Alcohols, C9-11, ethoxylated; Quaternary coco alkyl methyl amine ethoxylate methyl chloride < 5%.
